MyCarBudget Terms and Conditions

We provide a budgeted approach to managing your car expenses. You will pay us a Regular Payment through your Employer to meet the cost of the agreed supply by us of Fuel and selected Options such as Vehicle Servicing, and Tyres, Registration Renewal and Vehicle Insurance Payment. When you submit your application, you are requesting us to set and open a Budget for you. We can accept or reject your application. When we accept your application, these terms and conditions apply.

Definitions

In these Terms and Conditions: **Budget** is the budget we set (from time to time) for the expected annual cost of operating your vehicle with respect to Fuel and the applicable Options; **Budget Component** means a component of your Budget (such as for Fuel or an Option) for which we have allocated a separate annual budget within the Budget; **Budget Component Balance**, at any time, is the amount of the unused pre-payments we have received through your Regular Payments that we have allocated to a Budget Component; **Employer** means your employer, as named in your application; **Family Member** means your spouse, partner or adult child; **Fuel** means fuel, oil and car washes sold at authorised fuel suppliers who accept the Fuel Card for such transactions; **Fuel Card** means the fuel card we issue to you at your request for use at an authorised fuel supplier, such as Shell, Caltex or BP; **Monthly Fee** means the amount of \$9.95 payable as part of each Regular Payment; **Option** means an optional service that we have allowed for within the Budget and that we have agreed to provide under this agreement, such as for Vehicle Servicing, Tyres, Registration Renewal and/or Vehicle Insurance Payment; **Registration Renewal** means the agreed payment by us on your behalf of your vehicle registration renewal costs; **Regular Payment** is the monthly or periodic payment amount we notify to you and your Employer from time to time that is to be paid to us on your behalf by your Employer; **Recommended Budget Change** means a proposal from us to change the amount of your Budget and the amount of the Regular Payments. Such a request will include details of the recommended changes to any of the Budget Components; **this agreement** means your agreement with us on these terms and conditions, as later varied from time to time; **Tyres** means our agreed provision of tyres and tyre repairs; **Vehicle Insurance Payment** means the agreed payment by us on your behalf of your vehicle insurance costs for comprehensive vehicle insurance and/or compulsory third party insurance; **Vehicle Servicing** means our agreed provision of vehicle servicing, repairs and maintenance for your vehicle; **you** means the person named on the application; **your vehicle** means the vehicle nominated on your application (which may be the vehicle of a Family Member); **we** and **us** means Fleet Partners Pty Limited, ABN 63 006 706 832.

You will:

be liable for the GST inclusive cost of all goods and services we provide to you under this agreement, including under each Option; be liable to pay us the monthly fee, and to continue to do so while any amount remains owing to us under this agreement; be liable for making the Regular Payments to us to meet these costs and you must ensure that your Employer makes such Regular Payments to us on your behalf; not instruct your Employer to cease making the Regular Payments on your behalf while any amount remains owing to us under this agreement; promptly tell us whether you accept a Recommended Budget Change, and do so by email within 7 days of our telling you by email of the recommended change; only use the Fuel Card to purchase Fuel for your vehicle, or where your vehicle is owned by a Family Member, only allow the Fuel Card to be used for that vehicle; provide the odometer reading of your vehicle to the fuel supplier when purchasing Fuel; be liable for any transactions made using the Fuel Card, unless you have promptly notified us of fraudulent activity or the loss of the Fuel Card before the transaction occurred; regularly monitor your Fuel Card transactions and other transactions and tell us immediately of any errors or fraudulent transactions; not request any goods or service under this agreement for a vehicle that is not your vehicle; comply with any separate terms and conditions we provide to you from time to time that are applicable to the use of the Fuel Card; tell us of any material change in your financial circumstances – for example if you leave your employment or commence extended unpaid leave; advise us promptly if your vehicle is sold, stolen, lost or damaged to the point where it is not economically repairable; where you ask us to pay any Registration Renewal or Vehicle Insurance Payment under an agreed Option, provide us with a copy of the relevant renewal notice or invoice not less than 14 days prior to the due date for payment. (You must also ensure that any required statutory inspections are complete prior to asking us to pay for your registration renewal.); tell us immediately of any change to your address, email address or phone number; not assign or transfer your rights under this agreement.

We will:

set the Budget, each Budget Component, and the amount of each Regular Payment that is to apply from time to time; monitor the adequacy of the Budget and each Budget Component from time to time and propose Recommended Budget Changes where we think this is required; change the Budget when you agree to a Recommended Budget Change or, if you do not agree to a Recommended Budget Change within the required time, we may suspend our supply of some or all of the goods or services that we have agreed to provide under this agreement (or separately give you a termination notice under this agreement); adjust the amount of the Regular Payments to take account of any change made to the Budget; tell the Employer the amount of the Regular Payment that is to be made by the Employer on your behalf from time to time; provide you with the roadside assistance services described at www.mycarbudget.com.au, subject to any limits or conditions on our provision of such services that are listed from time to time at www.mycarbudget.com.au; provide you with a Fuel Card for use in purchasing Fuel; allow you a discount on the actual pump price of selected fuel types that you purchase with the Fuel Card, being the discount and the selected fuel types that are listed at www.mycarbudget.com.au as applicable at the time of the purchase; suspend your use of the Fuel Card if we consider an excessive and unexplained purchase of fuel has occurred during any month (assessed against the relevant Budget Component); provide the services that we agree to provide at your request under each Option applicable to this agreement (subject to any limits that we may impose from time to time); have the option to decline to provide a requested service under an agreed Option if it will involve us in bearing the cost (and therefore providing you with credit) for an amount, or for a period that is greater than we are prepared to accept at that time; apply each Regular Payment against the amounts due to us in respect of goods and services supplied to you under this agreement, and hold any unearned part as an advance payment against the future supply of goods and services under this agreement; allocate any such payments in advance against the Budget Components; not take or receive any money on deposit from you; provide you with a monthly or periodic report by email of your transactions during the statement period and of the level of your spending against the applicable Budget Components; not pay any fines, infringements or penalties on your behalf; not reimburse you for any expense you separately incur and pay to a third party in respect of your vehicle.

Other terms

You acknowledge and agree that: we are not your agent for any purpose under the agreement or in relation to any of the services we agree to provide to you; we will, subject to this agreement, use the Budget to calculate the amount of each Regular Payment to be made under this agreement; the Regular Payments are payable monthly (or at such other regular periodic periods as we agree with your Employer) until the term of this agreement has ended and all amounts due and payable to us have been paid to us by you or on your behalf; the first of the Regular Payments is due on the date we accept your application; the Regular Payments you make will be for goods and services supplied or to be supplied by us under this agreement; we are not authorised under the *Banking Act* and are not supervised by the Australian Prudential Regulation Authority and money paid to us will not be covered by the depositor protection provisions in section 13A of the *Banking Act*; we may reduce the amount of credit that we expect to provide you over a forthcoming period in respect of services to be provided under an Option by increasing the amount of the Regular Payments that will be payable for the first eight months of this agreement, or for the same period following the addition of an Option, (with a consequent reduction in the next four Regular Payments); no separate charge is made for any provision of credit to you under this agreement (although default charges may become payable if you fail to make a payment or repayment due under this agreement); we may charge you a default charge on any amount due and payable to us under the agreement where the default has continued for at least 14 days and where the default charge is calculated on the amount overdue at the penalty interest rate applicable in Victoria from time to time; by signing the application, and subject to our acceptance of your application, you are authorizing your Employer to make deductions from your salary to allow your Employer to make the Regular Payments on your behalf and to pay each Regular Payment to us and to not cease making the Regular Payments to us while you remain an employee and until we have advised your Employer that such payments are no longer required under this agreement; you have authorised us to discuss any matter or circumstance about your salary or about the status of your employment with your Employer; we may assign our rights under this agreement.

MyCarBudget Terms and Conditions (cont)

Variation of this agreement

Subject to giving you at least 32 days notice, or such shorter period as provided in this agreement, we can change the amount of the monthly fee, introduce a new fee or charge, offer an additional Option, withdraw an Option, change the services available for road side assistance or under an Option, or change the terms applicable to your use of the Fuel Card and to any process that is applicable to the operation of this agreement. We may also change the amount of the discount that is applicable to your purchase of selected fuel types at any time, but before we make such a change, we will provide 7 days prior notice of the proposed change at www.mycarbudget.com.au. You may tell us at anytime that you wish to cancel an Option. Where we or you do any of these things, we will advise you of any Recommended Budget Change and when we propose that such a change will take effect. We will also advise of any refund we propose to make to you for any unearned money paid in advance for a relevant Option.

Termination

You may terminate your rights under this agreement, at any time, by giving us notice in writing, but this will not affect the obligation to continue to make all required payments to us until all amounts due to us have been paid in full. Your rights under this agreement will immediately terminate if: you give us written notice that you do not wish to continue to receive goods or service under this agreement; your employment with your Employer is terminated; your Employer tells us that it will cease to make, or no longer make, the required Regular Payments on your behalf; or your Employer does not make a required Regular Payment and the default continues for more than 14 days. Your rights under this agreement will also terminate 32 days after we have given you notice that we will not continue to provide you with any goods and services after the 32 days have elapsed. Upon termination of your rights under this agreement, any unpaid amount for goods and services provided by us under this agreement shall become immediately due and payable to us. Your obligation to pay the Regular Payment (including the monthly fee) will continue until we have been paid all amounts owed to us under this agreement. If, following termination, all amounts due to us, or to become due to us, under this agreement have been paid in full, we will return any unearned funds paid to us in advance of goods or service to be provided but not now expected to be provided by us.

Liability Disclaimer

To the extent permitted by law, we exclude every warranty, condition, liability or representation concerning the supply of goods or services to you under this agreement. Where a product or service provided by us is defective, then to the extent permitted by law, our liability to you in respect of any goods supplied will be limited to one or more of the following: the replacement of the goods or the supply of equivalent goods; the repair of the goods; the payment of the cost of replacing the goods or acquiring equivalent goods; the payment of the cost of having the goods repaired. Where a service provided by us is deficient or defective, then to the extent permitted by law, our liability to you in respect of any services supplied will be limited to the supplying of the services again, or the payment of the cost of having the services supplied again. We will not be liable for consequential loss. You remain liable for the proper maintenance and care of your vehicle and for ensuring all necessary payments, including for registration and insurance have been validly made. You must advise us immediately of any payment not made or discrepancy in payment of which you become aware. We do not provide you with financial advice.

Other matters

When you arrange for Vehicle Servicing or Tyres, our OneCall team will discuss the servicing or repair requirements for your vehicle. We may be able to give you an indicative, non-binding, estimate of the expected cost for the required servicing or repair. However, such an estimate is simply a prediction, based on the information that you are able to provide at the time of your call. The actual cost that will be payable by you to us for the servicing or repair of your vehicle under an Option will be the actual direct cost that is charged to us by our supplier(s) for undertaking and completing the requested works and other services in respect of the servicing or repair of your vehicle. Our OneCall team is responsible for ensuring that only appropriate or necessary work is undertaken in the servicing or repair of your vehicle. Our team will not be required to seek your approval before authorising any works to be undertaken or before authorising any required expenditure, including in relation to the purchase of parts and other materials.

The fuel card remains the property of the fuel card issuer and must be returned to us upon request. All notices required under this agreement will be deemed to be delivered to you if they are sent to your provided email address. You may update your provided email address by writing to us or by sending details of your new email address from the email address currently held by us. You may ask us to change your Budget or make payment by facsimile transmission or by sending an email to info@mycarbudget.com.au from your currently provided email address.

Unless you have told us not to, we are authorised to send you marketing and promotional material relevant to the Options available from us.
